A non-refundable \$100 waitlist deposit reserves the purchaser's place for upcoming litters and remains valid for one (1) year from the contract date. Upon expiration, the deposit is void, and a new deposit must be submitted to retain an active waitlist position.

Your kitten comes with a Trupanion® pet insurance offer that begins **immediately** if activated **within 24 hours of pickup**. There is no waiting period when activated on time. Activation is optional but strongly recommended.

Veterinarian Examination & Health Guarantee

The breeder guarantees that, to the best of their knowledge, the kitten is healthy at the time of transfer. The kitten has received age-appropriate vaccinations, a fecal test, and a veterinary health exam, and is free from known contagious diseases and parasites.

The purchaser agrees to:

1. **Have the kitten examined by a licensed veterinarian within 72 hours** of leaving the cattery.
2. If a **pre-existing, life-threatening condition** is found, the purchaser must notify the breeder **in writing within 24 hours** of the exam and provide a copy of the veterinarian's written report.

If such a condition is verified, purchaser may choose:

- **Option A:** Return the kitten for a **full refund**, OR
- **Option B:** Return the kitten and receive a **replacement kitten of equal value** when available.

If the purchaser chooses **not** to return the kitten, all veterinary expenses become their responsibility, and **no refunds, reimbursements, or replacements** will be provided.

Genetic Health Guarantee (Two Years)

The breeder provides a **two-year guarantee from date of birth** against genetic, life-threatening illnesses.

If such a condition is diagnosed:

- Purchaser must notify the breeder immediately and provide veterinary documentation.
- A second opinion from a mutually agreed-upon licensed veterinarian may be required.
- If confirmed life-threatening and genetic, the purchaser may return the kitten for:
 1. A **full refund**, or
 2. A **replacement kitten of equal value**.

No veterinary or medical expenses will be reimbursed under any circumstances.

If the kitten passes away, a **necropsy report from a licensed laboratory** (at purchaser's expense) is required to confirm that the cause of death was genetic.

Exclusions

The breeder does **not** guarantee against any **viruses, infections, or contagious diseases** after the kitten has left the cattery.

Pawzilla's Go Home Guide

Purchaser acknowledges receipt of Pawzilla's Go Home Guide, which explains:

- Stress-related behaviors
- Temporary health changes
- Post-transition care

Purchaser agrees to read this guide **within the first 12 hours** of bringing the kitten home.

Payment Terms & Transportation

- All **deposits are non-refundable and non-transferable.**
- The deposit is applied to the purchase price and reserves the kitten.
- **Full payment is due 48 hours before any transporter receives the kitten,** or at the time of in-person pickup.
- Kittens must be picked up by **12 weeks of age.**

Accepted Forms of Payment

Zelle, Cash App, Apple Pay, Venmo, or PayPal (no fees or add 4%).

Transportation Policies

- All transportation (including flight nanny services) is paid **directly to the transporter.**
- Purchaser is responsible for all transportation costs.
- Breeder charges a **\$50 gas fee** for trips to RDU Airport (Raleigh).
- Once the kitten is in the care of a transporter, the breeder is **not responsible** for any injury or issues.
- Purchasers are encouraged to thoroughly research and verify their chosen transporter.

Buyer's Obligations & Expected Home Life

The purchaser agrees to provide:

- A safe, lifelong home
- High-quality food and clean water
- Routine veterinary care (annual exams, vaccinations, parasite prevention)

Failure to keep the kitten up-to-date on **annual exams and vaccinations** voids this contract.

Purchaser agrees:

- **Do NOT declaw the kitten.**
- **Do NOT allow the kitten to roam outdoors.**
- Any illness or injury occurring after the kitten leaves the breeder is the purchaser's responsibility.
- Do not expose the kitten to unvaccinated or unhealthy cats.

Breeding, Showing & Spay/Neuter Policy

All kittens are sold **as pets only** under a **SpaySecure** spay/neuter agreement.

If breeding or showing rights are desired, this must be **discussed and approved prior to purchase**.

If breeding/show rights are **not** granted:

- Any attempt to breed or show the kitten violates this agreement.
- Failure to complete spay/neuter requirements will result in **legal action by SpaySecure**.

Breeder makes no guarantees regarding future breeding or show potential for kittens sold with rights.

Return & Refund Policy

We do not refund for buyer remorse or for cat allergies. Please make sure everyone in the household is in agreement and aware of any allergy concerns before placing a deposit, as all deposits are non-refundable and non-transferable.

Pawzilla Maine Coon Cattery will always accept a kitten back at any age if you can no longer keep them; however, **no refunds will be issued** in these situations.

Refunds are only available under the conditions outlined in the **Health Guarantee** and **Genetic Guarantee**.

- Veterinary health records
- Starter food
- Prepaid microchip (with paperwork)
- 30 days of Trupanion insurance (if activated within 24 hours)
